Minutes of **MEETING of RENHOLD PARISH COUNCIL** held on **Wednesday 24th November 2010** at 7.30pm in the Committee Room of Renhold Village Hall.

PRESENT:- Parish Councillors, Mr. Slater (Chairman), Mr Andrews, Mr. Gurney, Mrs. Dean, Mrs. Brunsden, Mr. Stapleton, the Clerk Mrs. Barnicoat & 5 members of the public.

1. WELCOME BY CHAIRMAN AND APOLOGIES TO BE RECEIVED: - Cllr. Slater welcomed everyone to the meeting and apologies for absence were received and accepted from Borough Councillor Ellis and Mr. Leydon.

The Chairman adjourned the meeting for the next item.

2. **OPEN FORUM:-** Topics raised included information for residents available regarding digital switchover, suggestion of collating a village information pack and an update of petition being collected for the relocation of the school.

The Chairman re-convened the meeting.

3. DECLARATIONS OF PERSONAL AND PREJUDICIAL INTEREST: - None received.

4. MINUTES OF THE LAST MEETING:-

The minutes of the meeting held on 25th October had been circulated. The minutes were approved, unanimously agreed, resolution passed and signed by the Chair as a true and accurate record.

5. MATTERS ARISING:-

a) Litter pick – this had been booked for 4th December and posters displayed on all notice boards.

b) Parish Election costs 2011 – Borough have informed that if parish election is uncontested estimated cost to be £250 to £300, however, if contested in the region of £1450 and £1750.

6. PARISH COUNCILLOR VACANCY: - The Clerk had received one expression of interest and statement of information had been circulated to all Councillors prior to the meeting. Cllr. Slater proposed that Ian McDougall be co-opted as a Parish Councillor, seconded by Cllr. Gurney, unanimously agreed by those present, resolution passed. Mr. McDougall was welcomed and joined the Council, Clerk noting no formal participation in the meeting as formal summons had not been issued. Declaration of Acceptance of Office and Register of Interest forms was completed by Mr. McDougall.

7. **BOROUGH COUNCILLOR REPORT:** - Cllr. Ellis not present but report received detailing new ward arrangements, ward funding, police promotion campaign of safe driving and winter weather precautions being undertaken by the Council.

8. HIGHWAYS UPDATE: - Cllrs Leydon, Dean, Gurney, Stapleton and Slater had attended meeting with neighbouring parishes and it was reported that ways to encourage other villages to participate in working together to promote road safety and how best to share ideas were discussed. It was felt the police Joint Action Group meetings would be a useful tool to raise and promote awareness to parish councils and residents. The Borough's Rural Transport road show had visited the village recently, Cllr Slater reported that he, Cllr. Gurney and three residents had been in

attendance but the Borough Officers had been very helpful and listened to the concerns raised. Simon Deards response had been circulated to all prior to the meeting and it was noted that the more information that could be gained regarding lorries in the village and a recording system that could be in place would then allow the Borough to pursue and enforce. It was also reported that an additional signage for the Traffic Regulation Order at the B660 end of the Order had been installed recently and the requests for the traffic flow survey and gated entrance were still being pursued.

10/02089/LBC extension to outbuilding to provide self contained annexe at 65 Church End – planning permission withdrawn.

a) 10/02593/LBC flat roof extension at 52 Green End – the Council agreed no objection to listed building consent.

b) Bedford Conservation Area Management Plan and a Design Framework for Pubic Realm Works for Bedford High Street – information regarding this consultation had been circulated to all, it was agreed that Councillors to make individual comments if they wished.

c) Electoral Review of Bedford final recommendations regarding ward boundaries - the final recommendations and agreement of changes had been received and circulated. The Council expressed sadness at being part of a large two member ward and noted that the Parish Council had been re-warded and from May 2011 would be comprised of two members from Cranbourne Gardens, two from the Spires and five members from the remainder of the village.

OTHER PLANNING MATTERS: - The Clerk had submitted response to recently published Covanta application for Rookery South, Stewartby.

10. QUALITY STATUS PROGRESSION:-

It was noted that the Finance Committee will be considering the cost of quality status at there next meeting.

11. EMPLOYMENT WORKING GORUP:-

Cllr. Andrews read report following meeting of Working Group and Clerk's annual appraisal, it was noted that the Clerk's job description and contract had been reviewed and amendments suggested.
