Minutes of **MEETING of RENHOLD PARISH COUNCIL** held on **Wednesday 23**rd **February 2011** at 7.30pm in the Committee Room of Renhold Village Hall.

PRESENT: Parish Councillors, Mr. Slater (Chairman), Mr Andrews, Mr. Gurney, Mrs. Dean, Mr. Stapleton, Mr. McDougall, Mr. Bernard, Mrs. Brunsden, Borough Councillor Ellis, the Clerk Mrs. Barnicoat & four members of the public.

1. WELCOME BY CHAIRMAN AND APOLOGIES TO BE RECEIVED: - Cllr. Slater welcomed everyone to the meeting and apologies for absence were received and accepted from Mr. Leydon.

The Chairman adjourned the meeting for the next item.

2. OPEN FORUM:-

A member of the public enquired regarding the progression of the remedial work at Persimmon.

The Chairman re-convened the meeting.

3. DECLARATIONS OF PERSONAL AND PREJUDICIAL INTEREST: - None received.

4. MINUTES OF THE LAST MEETING:-

The minutes of the meeting held on 12th January had been circulated. The minutes were approved, unanimously agreed, resolution passed and signed by the Chair as a true and accurate record. Cllr. Gurney at this point of the meeting noted that during the research undertaken in relation to the village sign it had come to light that the county archive records were missing some of the parish minutes, Clerk to look into.

5. MATTERS ARISING:-

Cllr. Slater reported that comments had been submitted regarding a listed building application request at Harrisons Farm, the plans were identical to the full application so comments identical to those discussed at the previous meeting were submitted. The Officer had notified the Council that alterations had been made to the application, but to date no formal notification had been received regarding this.

- **6. BOROUGH COUNCILLOR REPORT:** Cllr. Ellis reported on the Borough Council budget for 2011/12, HGVs, school funding and Borough Councillor ward fund. Information was given and discussed regarding the mobile hand held speed gun that Cllr. Ellis had recently purchased and a potential strategy for using the device, on arrival of the device a training date and invite to be circulated to all parishes within the ward.
- 7. HIGHWAYS UPDATE: The Clerk reported that response received regarding the gated entrance request noted that currently no highway funds available for the project. However, a request could be submitted in the new financial year and the Parish Council were welcome to make a contribution to the cost, Clerk to liase and find out the estimated cost of four gated entrances. The forthcoming Capital Works programme was circulated and discussed as highways had requested each parish forward three schemes as their priority, it was agreed that the top three schemes were footway treatment on Brickfield Road, Church End continuation of kerbing to bus shelter, and Wilden Road surface treatment. Other works listed in the parish would be pursued by

the Council with highways to ensure as many works are carried out to improve the highways in the village. Also discussed in detail was the Borough's Local Transport Plan and the freight strategy document in relation to it which Cllr. Ellis reported on following a specific meeting with a highways officer regarding this matter and highlighting the need and urgency of a freight ban being imposed. Other matters discussed by the Council included traffic data response received from the Borough but awaiting detailed analysis and Clerk had pursued the police for feedback from the Lower School poster competition which Renhold had not been included in, still awaiting response.

8. PLANNING AND DEVELOPMENT: -

PLANNING APPLCATIONS RECEIVED: - 11/00083/FUL two storey rear and side extensions at Dairy Farm Cottage, St Neots Road – the Council discussed this and agreed they had no objection to the application.

OTHER PLANNING MATTERS: - Following the approval of the advertising consent relating to the new Norse Road development it was noted that no letter received to date from Planning Officer explaining the reason for the decision, Clerk to enquire.

9. REPORTS FROM MEETINGS COUNCILLORS HAVE ATTENDED: -

Cllr. Slater detailed a report following attendance at the recent Town and Parish Network meeting, noting that matters discussed included special area charges, Town and Parish Conference and 2011 census.
