Minutes of **MEETING of RENHOLD PARISH COUNCIL** held on **Tuesday 26th February 2019** at 7.30pm in the Renhold Village Hall, Wilden Road.

PRESENT:- Parish Councillors: Mr. Slater, Mr. Gurney, Mr. Cook, Mrs Brunsden, Mrs. Quince, Mrs. Dean and Borough Councillor Stephen Moon, the Clerk Mrs. Barnicoat and seven members of the public.

1. WELCOME AND APOLOGIES FOR ABSENCE TO BE RECEIVED: - Cllr. Slater welcomed everyone to the meeting and thanked everyone for attending; it was noted that Borough Councillor Jade Uko, and Parish Councillors Mrs. Gribble and Mr. Polhill had sent their apologies which were accepted.

2. DECLARATION OF PERSONAL AND PREJUDICIAL INTERESTS:-

There were no declarations received.

The Chairman adjourned the meeting for the next item.

3. OPEN FORUM: -

Request for dog waste bin at Top End by Boff House.

Hookhams Lane hedge untidy and littering, please report. Clerk had already done this. Borough Council had done the work, disappointing to see debris left.

Suggestion of litter bin at Hookhams Lane.

Litter pick request for bypass roundabout and area at Water Lane.

Suggestion of engaging with school to do a community litter pick event, Cllr. Quince to follow up. Volunteers in parish who regularly litter pick were thanked for their efforts.

Sign opposite village school needs to be removed and replaced with primary school sign.

The Chairman reconvened the meeting.

4. MINUTES OF THE LAST MEETING:-

The minutes of 14th January unanimously agreed, signed by the Chair as a true and accurate record.

5. MATTERS ARISING:-

Officer communication regarding signage request for children playing signs in Cranbourne Gardens. Clerk has sought clarity on this and Borough Council need more information, so Clerk has checked with the resident who asked for this originally.

Officer communication on the reported littering issues by the bridleway at the Polhill Arms. Clerk has chased this up and more recent patrols have taken place, feedback also given to resident who raised this originally.

Clerk reported fly tipping and littering by the Polhill Arms.

Planning responses submitted from last meeting.

6. BOROUGH COUNCILLOR REPORT:-

Received, and responses to the East West Rail consultation encouraged.

7. HIGHWAYS MATTERS WITHIN THE VILLAGE: -

Officer feedback on Hookhams Lane feasibility study detailed, Clerk to monitor.

A428 Black Cat to Caxton Gibbet Route Announcement circulated.

Borough Office feedback given on costings for average speed camera schemes.

Pedestrian crossing by school update given. Cllr. Quince reported on parking enforcement by the school, number of tickets issued. Engagement continues with the school and Borough Council.

8. PLANNING AND DEVELOPMENT: -

a) East West Rail public consultation regarding route for Bedford to Cambridge – Clerk to submit response highlighting minimal detail in consultation was not helpful, and the route should have minimal impact on the rural environment, therefore with spoiled corridors already, the route should go to the south of Bedford. This would also reduce congestion in town. Cllrs Quince and Cook to attend Parish Council briefing session.

b) Update on planning applications for proposed new dwellings in the parish:

18/02565/FUL erection of new dwelling with detached garage at land to rear of Wentworth House, Ravensden Road – decision expected shortly.

18/02496/MAF demolition of one dwelling and erection of 14 dwellings at 27 Hookhams Lane and land adjacent - no new information.

8/02692/OUT Outline application for the erection of 2 dwellings with all matters reserved except access at Land Adjoining 56 Top End – no new information.

c) 19/00284/FUL single storey rear extension, conversion of garage to living accommodation at 20 Thor Drive - noted that in order for a vehicle to access the driveway to Number 20, it would have to cross over another driveway to get off the road, so there are concerns regarding this as parking is already an issue in this area.

d) 19/00210/LBC timber clad box to cover electrical services box to be in keeping with the existing building at Church Farm Barn, Church End - object with regard to visual impact this will have on a listed building. As it is placed on a brick wall, the box needs to be built to match the wall, so of a brick structure and tiled on top.

e) 19/00200/FUL erection of two storey front extension to accommodate garage with room over, raising of bungalow roof and installation of dormer windows to all elevations to facilitate loft conversion at Elmleigh, 18 Wilden Road - object as the proposals are forward of the existing building line.

f) 19/00112/LBC and 19/00111/FUL restoration and refurbishment of Great Dairy Farmhouse and associated outbuildings at Great Dairy Farm, 6 St Neots Road - object on the principle that this application proposes to build new dwellings outside of the settlement policy area. The Council, however, do support the development of the Farmhouse as it would be good to see it brought back to a good condition.

g) 19/00384/FUL replacement garage with single storey side/rear extension, and single storey rear extension at 8 Home Close – (Cllr. Slater declared an interest and took no part in discussion) Council had no objection.

h) 19/00152/FUL single storey rear extension to link to garage and part conversion of garage to utility room at 14 Thor Drive – no objection.

i) 19/00066/FUL at Three Horseshoes site, Top End – Officer had granted extension for Parish Council response, Council requested Cllr. Moon to call into Committee. It was agreed to object to the application as it does not provide the community facility that was the subject of the previous proposal.

j) Other planning matters included application decisions – 27 Asgard Drive approved, 29 Top End withdrawn.

9. UPDATE ON WORK DONE TO DATE RAISING AWARENESS OF FORTHCOMING LOCAL ELECTIONS IN MAY: -

Election summary document to be issued in next village magazine, placed on Council website and noticeboards. Clerk attended election drop in session at Borough Hall, feedback given.

Clerk in receipt of paper copies of the nomination packs and electoral register for the parish. Election information in Council annual report, and village circulation communication to be done.

10. PARISH COUNCILLOR VACANCY: -

No interest received.

11. VILLAGE MATTERS: -

Annual report of Parish Council drafted, Clerk to update then agreed to be sent to JCB Printing, ready for circulating at end of March.

Agreed that Mr Chambers to install bench to be located in Cranbourne Gardens. Awaiting landowner's permission.

Quote for the Remembrance memorial circulated, agreed to purchase 4ft bench at cost of £810, to be delivered to contractor who would install.

Rural Bulky Waste service dates confirmed.

Cllrs. Dean and Gurney to attend police priority meeting. Broadband meeting with Alastair Burt MP noted.

New police contact information published.

Letter to all Parish Councils from PCC Kathryn Holloway circulated. Council welcomed greater police presence. Clerk to circulate information on CCTV - another parish is pursuing this.

Clerk to find out if Orbit Sports facility is available for hire as a possible future meeting venue.

Hedge by Polhill Arms has been cut back noticeably by Borough Council. Disappointment at site not being left presentable to be reported.

Dog bin request at Top End discussed, agreed application to be made for a multi purpose bin to the Ward Fund when it opens.
