Minutes of MEETING of RENHOLD PARISH COUNCIL held on Thursday 20th June 2019 at 7.30pm at Renhold Village Hall

6. BOROUGH COUNCILLOR REPORT: -

The Goldington Ward Councillors had sent a report which was circulated.

The Great Barford Ward Councillors had sent a report which was circulated.

7. HIGHWAYS MATTERS WITHIN THE VILLAGE: -

- a) Feedback from Bedford Borough Council Engineer following feasibility study of Hookhams Lane undertaken to look at traffic calming options a full list of questions had been sent to the Engineer and author of the study.
- b) To receive update regarding the proposed consultation for a safe pedestrian crossing at Church End it was agreed that support could not be given in principle until more information is known in order to fully understand what type of crossing is being considered and potential wider implications this may have. Clerk to arrange meeting with relevant Senior Officers to ensure that what has been explored by the Local Authority is better understood.

There have been a number of Speedwatch and HGV checks in the parish recently. Our thanks recorded to those so actively involved on our behalf.

8. PLANNING AND DEVELOPMENT: -

a) Update on planning applications for proposed new dwellings in the parish:

18/02565/FUL erection of new dwelling with detached garage at land to rear of Wentworth House, Ravensden Road – Officer awaiting further report from applicant.

18/02496/MAF demolition of one dwelling and erection of 14 dwellings at 27 Hookhams Lane and land adjacent, revised drawings submitted – Council continue to object to the site being developed, noting that the changes to the drainage surface run off continue to raise concern over the known drainage issues already identified on this site.

- b) 19/00066/FUL erection of three detached houses with detached garages and parking at land at former site of Three Horseshoes, Top End revised drawings submitted The Council note the change in designs to the proposals, however, fundamentally the Parish Council do not change their opinion on the need that this site must be retained for a community facility. The house designs are out of keeping with the street scene. The Council feel that the dwelling opposite the site is a good example of a modern building which is in keeping, with the nearby St Margaret Cottages. What has been proposed does not bring harmony to this part of the village. Furthermore, the Council feel that swift bricks should be encouraged to attract wildlife as this is important to the village. Also the Parish Council feel that when drawings are submitted, the plots should be shown in their full setting so the nearby houses should be illustrated to show how they sit within the current street scene.
- c) 19/00552/FUL loft conversion with front and rear roof windows at 45 Primrose Fields no objection.
- d) 19/00963/FUL removal of existing smoking shelter and erection of covered pergola structure at Polhill Arms, Wilden Road no objection, though could a screen please be erected between the smokers and other users.
- e) Other planning matters to include application decisions:

18/03072/FUL Water Lane erection of 2 storey dwelling with basement structure – awaiting decision

17/03351/EIAWM Extraction of sand and gravel; installation of mineral processing plant; construction of a quarry access onto St Neots Road; installation of a temporary access road crossing the River Ouse; and restoration of extraction area partly using imported inert material. at land either Side Of Willington Lock, St Neots Road – application granted

19/00566/FUL Single storey extension to link house with outbuilding and alterations at Wood House, Wood Lane – application permitted

18/02181/FUL Erection of detached bungalow with detached single garage at land fronting 14 Wilden Road has gone to planning appeal INSPECTORATE NO: APP/K0235/W/10/3228659

Bedford Borough Community Statement of Involvement consultation response to be submitted by Clerk. to include the challenges of paper applications not being fully provided so it makes it inaccessible to view/discuss plans at meetings. Often inaccuracies with the administration of planning, Case Officers not being easy to contact/locate, there are also online challenges with locating appropriate documents for an application-particularly as they seem not to be dated or in chronological order.

9. PARISH COUNCILLOR VACANCY: -

Proposed by JP, seconded by SB that Nicky Gribble be co-opted to the Parish Council, unanimously approved. Clerk to issue documentation.

10. VILLAGE MATTERS: -

Village assets maintenance review schedule discussed, items to be identified by Councillors, then quotes to be sought. IM to review two bus shelters and produce a check list to aid with monitoring on a quarterly basis going forwards, JP to review bench by old school, IM to review Church End noticeboard.

Anti-social behaviour at Water End, MW to maintain a log of incidents to be sent on to local authority to show why signage and CCTV is so vital in this area.

Noted limited noticeboard capacity at Orbit development, DR to be asked for guidance on where to locate PC notices ensuring residents are kept up to date.

Agreed to look into village defibrillator costings for the potential siting by the Green End bus shelter, IM to review and Ward Fund application could be made.

Celebrating next year's VE Day it was agreed enquiries to be made on potentially booking the Village Hall, then at the September elector meetings interest to be obtained by other groups as to how they wish to commemorate this significant event. A communication to be collated for displaying on the noticeboards and website to highlight the important day, AQ to forward on.

Clerk to alert Police that the Council is supportive of the alignment of the three developments off Norse Road siting with the Goldington Ward police area.

Agreed live streaming of Parish Council meetings not to be pursued at this time. Agreed to alternative means of community engagement with regular Councillor surgeries in the village to afford residents, who may not be able to attend meetings, the opportunity to speak directly to Councillors about village matters that concern them. Dates to be collated. Council pleased to see large number of residents in attendance at this meeting and welcomed their contribution.

11. COMMUNITY COHESION IDEAS FOR THE PARISH MOVING FORWARDS: -

Reintroduction of Renhold Relay from The Polhill Arms, Rogationtide, beating the parish boundaries. Both ideas could potentially be combined with VE celebrations. Bedfordshire Young Farmers' Rally being held at Howbury Hall on 16th May. It was agreed that it would be good to have a presence to promote the village, perhaps in a 'village tent'. Community litter pick is being

pursued with the school and date to be agreed . Community Emergency Response training to be investigated. All items to be added to future agenda.
